Regardless of the above cut-offs in any of the above programs, a self attested GATE score card must be produced on the day of the interview explicitly stating that the candidate has qualified in GATE 2017/ GATE 2018/ GATE 2019 (the word 'qualified' must appear clearly in the score card).					
Percentage or CGPA will be considered only as per the <i>grade sheet</i> provided by the institute/university. No conversion from CGPA to percentage or vice-versa by the candidate or his/her institute will be entertained.					

Important Note: For MS(R) Applicants: An MS(R) candidate (EE Dept.) can appear for interview in any of the two committees where he/she satisfies the short listing criteria listed above for the following committees: 1. EEA, 2. EEE, 3. EEN, 4. EEP, 5. EES, 6. EET.

Additionally Graduate from CFTI are eligible for waiver from the requirement of GATE for admission to M.S.(R) programme with CGPA of 8.0 or above as per Senate Resolution No. S/11/2019 (Attached)

Examples:

1. If Mr/Ms. X a GEN Full-Time candidate has a GATE score of 750, he/she can present himself/herself for MS(R) interview for specialization in any two of EEA, EEN, EEP, & EES. He/she will not be eligible to attend interview for specialization in EEE & EET.
2. If Mr/Ms. X an OBC Full-Time candidate has a GATE score of 740, he/she can present himself/herself for MS(R) interview for specialization in EEP & EES. He/she will not be eligible to attend interview for specialization in EEA, EEE, EEN, and EET.
3. Similarly for other categories and Part-Time candidates.
